MISSION. 2nd Bn (Rein), 1st Mar (-) (Rein) defends PHU BAI Airfield and 8th RRU; controls assigned TAOR; conducts combat/reconnaissance patrols throughout assigned TAOR; conducts unilateral search and destroy operations in assigned TAOR and combined operations with RVNAF within and beyond boundaries of assigned TAOR. Prepares defense and counterattack plans to restore integrity of defensive perimeter to include PHU BAI Airfield and 8th RRU facilities.

10. BACKGROUND. To accomplish the assigned mission the Battalion TAOR has been divided into company sectors with each rifle company conducting aggressive patrolling, sweeps and numerous ambushes in their assigned sector. The companies defend their portion of the MIR by employing observation posts, listening posts, road blocks, checkpoints and through occupation of prepared positions in critical areas.

a. The Enemy Situation on 22 December was as follows:

There are no known enemy units operating within our TAOR, enemy activity within TAOR consisted of ambushes and patrols with infiltration of men through our TAOR in order to gather food, spread political information and propaganda, and reach other areas for operations.

Enemy units that operate near our TAOR are:

(1) 810th Battalion, a probable Main Force Unit; strength, 360 men. Equipped with 3 81mm Mortars; 3 57mm RR; 3 CHICOM machine guns; B-40 (RPG) anti-tank weapons (vic YC 870970).

(2) K 41/G-106 Company, a main force unit; estimated strength 100 men, located vic YC 950985.

(3) C-116, a Local Force Unit, estimated strength, 100 men. located vic 860045.

(4) C-117, a Local Force Company. strength, 80 men, located vic YD 810065.

(5) C-119, a Local Force Company: estimated strength 100 men, located vic YD 780115.

b. The enemy initiated the following incidents during the period:

(1) 242030H. VC threw 2 Hand Grenades at USMC patrol; location YD 814179. Results: 1 VC KIA, 1 VC WIA (Poss.).

(2) 281217H. Sniper fire via YD 875103, came from northwest. One round, col. unknown.

(a) Squad sized. There were 78 Squad Sized patrols conducted.

(b) Platoon Sized. There were 2 Platoon Sized patrols conducted.

b. Significant Events

(1) Sequential listing of all contacts, general description of scheme of manuever and results attained.

(a) 23 December - 2nd Battalion, 1st Marines assumed control of TAOR relieving 3rd Battalion, 4th Marines. There were 8 Squad and 1 Platoon size patrols conducted. 4 Ambushes and 12 Listening Posts were employed. Negative contact.

(b) 24 December - At 2030H CAC-2 made contact with estimated 2 VC. Illumination was fired in support with CAC-2 taking VC under fire. After contact was broken a sweep of the area was conducted with negative results. At 2215H message was received from CG, 3rd Marine Division as follows: "Do not respond to minor perpetrations or harassment as long as they do not pose a threat to security. 8 Squad size patrols were conducted. 3 Ambushes and 12 Listening Posts were employed.

(c) 25 December - 7 Squad Patrols were conducted. 4 Squad size Ambushes and 14 Listening Posts were employed. All units were again instructed not to fire unless fired upon. No unusual incidents happened.

(d) 26 December - At 0930 2nd Battalion, 1st Marines received orders to resume normal operations from Regiment. 8 Squad size patrols were conducted, 5 Squad size Ambushes and 14 Listening Posts were employed. Negative contact.

(e) 27 December - At 0130, 2nd Platoon, Company E, in the GIA LE area had contact with two VC with possible one VC WIA. 8 Squad size patrols were conducted. 4 Squad size Ambushes and 15 Listening Posts were employed.

(f) 26 December - CAC-5 at 2130 made contact with 4 VC, patrol physically pursued VC with no results. No friendly casualties. One mechanized, motorized patrol at 1000 to 1400. Purpose of patrol to perform road reconnaissance and to get actual time/speed factor for possible future operation. Route from 844173 to 808103 and return. 8 Squad size Patrols were conducted, 3 Squad size Ambushes and 14 Listening Posts were employed.

(g) 29 December - Reconnaissance Patrol at 1715 made contact with 5 VC. Pursued them approximately 800 meters, did not pursue further because of heavy foliage and village. Not enough men in patrol to pursue further. No friendly casualties. No VC casualties. 10 Squad size Patrols were conducted, 3 Squad size Ambushes and 14 Listening Posts were employed.

(h) 30 December - 11 Squad size Patrols were conducted, 4 Squad size Ambushes and 14 Listening Patrols were employed. Negative contact.

(i) 31 December - 2145H, 2nd Platoon, Company G at 19102 received fire from 4 or 5 VC's. One friendly KIA. VC casualties unknown. 1 Platoon size Patrol and 10 Squad size Patrols were conducted. 8 Squad size Ambushes and 15 Listening Posts were employed.

ARTILLERY SUPPORT AND FIRE SUPPORT COORDINATION

a. Significant Events.

At 0755H on 1 Dec, the Howtar Battery displaced five guns to (YD 882136) during the conduct of a battalion firing demonstration. The demonstration emphasized massing the fires of the battalion on defensive concentrations, and firing the barrage with the Howtar Battery. Later in the day, a U.S. Army Calibration team calibrated the 18 howitzers in the 4th Battalion.

During the night of 1 Dec, at 2000H and 2125H, illumination missions were fired for elements of 3/4 in contact with VC at (YD 816174) and (YD 921111). Both missions were completed but no surveillance obtained.

On 2 Dec, I Battery displaced four guns to (YD 882116) at 0730H and Battery M moved two guns forward to (YD 859118) at 1140H. Battery I conducted observed missions on suspected enemy positions in the west sector of the TAOR, and M fired H&I missions.

At 021305H, the AO adjusted M on 2 VC at (YD 783094). The area was well covered, but no surveillance of the enemy was obtained after firing.

The Howtar Battery conducted a night occupation of positions moving to (YD 872130) at 021900H and returning to their primary positions at 2130H.

I Battery fired ten observed missions on suspected VC harboring sites and avenues of approach in the southern portion of the TAOR on 3 D Dec. The Battery occupied a forward position at (YD 877123) at 0915H, and returned to primary position at 1550H after firing several H&I missions.

At 031850H, an AO attached to 3/4 requested fire on a squad of VC at (YD 880075). No surveillance of the mission was possible due to darkness.

Two rounds of illumination and seven rounds of HE were fired in support of a 3/4 ambush at 032010H in the vicinity of (YD 9607). No surveillance was obtained.

At 050755H the Howtar Battery displaced to (YD 868118). Ten observed missions were fired on suspected assembly areas, avenues of approach, and CPs in the western portion of the TAOR. The missions were observed by an OP group of Scout Observer Trainees manning OP Range (YD 855733).

Between 050430H and 050500H the battalion fired a preparation for ARVN on a sweep SW of the TAOR near TRUOI BRIDGE. Later in the day, members of the new K Co, 3/4 were alerted by firing in their defensive concentrations with shell sacks.

M displaced two guns to (YD 862116) at 061300H, and fired 22 H&I missions beyond the normal maximum range from their primary position. In the afternoon of 6 Dec, LtGen V. H. KRULAK toured the battalion civil affairs project in the refugee villages of DIEM TRU, KE BANG, and PHAN DANG (YD 8616).

At 061915H I displaced four guns to a forward position at (YD 875139) and conducted coordinated illumination and HE missions until 2130H.

M fired on one VC at (YD 770077) at 061800H. Surveillance reported good effect on the target area. Two illumination missions were fired during VC contact at (YD 907099) and (YD 905090) during the night of 6 Dec.

At 080030H four M-109 (SP) and three towed 155mm howitzers were moved to (YD 855118) in support of Operation GUNSMOKE, a Marine and ARVN sweep on the west bank of the SONG HONG River from (YD 741161) to (YD 748143). Two of the towed howitzers were manned by personnel from I Battery. Two missions were fired in support of the operation. A VC ambush was dispersed by one mission at (YD 733161) and an unobserved mission was fired on a suspected VC stronghold at (YD 736138).

The Howitzer Battery conducted a night occupation of a position at (YD 861142) on the night of 7 Dec.

On 7 Dec, the Howitzer Battery fired 21 observed missions on suspected VC positions from a forward position at (YD 883092). An OP was established on Hill 103 (YD 871077) and manned by Scout Observer Trainees. I Battery displaced to (YD 815139) at 091822H and fired one coordinated illumination and HE mission before returning to their primary position at 2130H.

Daylight H&I missions were fired by M from a forward position at (YD 859118) on the afternoon of 10 Dec.

At 100100H, an undetermined number of VC attacked the HUONG THUY District HQ with mortars. Three unobserved defensive concentrations were fired at the request of ARVN, and the EQ Crater Analysis Team went to the area during the day. At 0735H on 10 Dec the VC destroyed a post at (YD 818034).

Illumination was fired for ARVN at 102200H during a light VC probe at (YD 760130). Later in the night, at 110140H, M fired illumination for M 3/4 during a contact which resulted in 4 VC KIA, 1 prisoner, and 5 weapons captured.

On 11 Dec at 0715H, I displaced four guns to (YD 868113) and fired 13 observed missions in the southern sector of the TACH on suspected VC locations.

M fired 14 rounds of HE on four VC in a treeline at (YD 793092) at 111600H. Excellent effect on the area was reported and no subsequent movement was observed. M later fired three unobserved missions on a VC company at the request of ARVN in the vicinity of (YD 790080). On the night of 11 Dec M conducted a night occupation of a forward position at (YD 871139), from which two coordinated illumination and HE missions were fired.

At 150730H, the Howzer Battery displaced to (YD 895080) and fired ten observed missions on suspected VC positions in the southern part of the TAOB. At 1900H, I displaced three guns to (YD 859113) and fired H&I missions throughout the night, returning to their primary positions at 240630H.

The AO observed a body at (YD 802075) at 141400H. It was assumed to be a victim of an H&I round.

At 181400H, two guns from M occupied a forward position at (YD 331131). While they were enroute to the position, the AO requested fire on four VC on a raft at (YD 731103), which is out of range of the guns in the primary positions. The guns conducted a hasty occupation of position and completed the mission in 11 minutes. The VC deserted the raft and swam to shore, and good effect was reported on the shoreline.

I battery displaced to (YD 859118) at 141740H and fired H&I missions overnight.

On 15 Dec, the three firing batteries and a Battalion Command Group moved to forward positions for the day. The Howzer Battery occupied a position at (YD 863092). I Battery moved three guns from their overnight position to (YD 881116), and M displaced two guns to (YD 860116). The Battalion FDC (Fwd) was established adjacent to I Battery. 14 missions were fired in the southern part of the TAOB, emphasizing messing the fires of the battalion, requesting reinforcing fires, and TCC procedures.

During the night of the 15th, two unobserved missions were fired in support of 3/4th Combined Action Company (CAC) during a VC contact at (YD 902121).

At 172450H, three defensive concentrations were fired at (YD 740090), (YD 780090), and (YD 760110) when the ARVN outpost at HAH HOA came under a light attack. No surveillance was received.

I displaced four guns to (YD 859116) at 181530H to fire H&I missions. The battery returned to its primary position at 190730H.

At 182000H, illumination was fired on 3 VC crossing route 1 at (YD 903122). No further contact was established.

The battalion fired two observed and five unobserved missions in the vicinity of OR ORW (YD 849036) at 211500H in support of 3/4th Mobile Strike Force. Contact was not maintained.

B Battery, 1/11 arrived at 211830H to relieve I, 3/12. I Battery departed position at 220615H.

During the day on 22 Dec, the Battalion fired on a reported VC company at (YD 987150). A subsequent sweep of the area yielded four hand grenades. At 173H the AO adjusted M Battery on one VC at (YD 772030). Good effect on the area was reported.

W, 1/11 relieved W, 2/12 at 230600H.

During the morning of the 23d, Howtar and B Battery commanders were given an orientation of forward firing positions in the TAOB, and at 1300H, B displaced four guns to (YD 868113) and W four guns to (YD 859118). Ten observed missions were fired.

On 24 Dec the AO fired on two VC at (YD 971078). A possible secondary explosion was observed. At 0930H M displaced two guns to (YD 868113). Four observed missions were fired on suspected avenues of approach to the south of the TAOB.

On Christmas Eve, parties were held for the children in the refugee villages of BINH TRU, PHAN DANG, and KE DANG. 242 families and 637 children attended.

At 24300Z four rounds of illumination were fired for a CAC patrol engaged with two VC at (YD 910113). This was the last firing until the end of the cease fire on 26 Dec. Activities were resumed by firing 15 RM missions during the afternoon of the 26th.

The Howtar Battery displaced to (YD 868113) and B Battery to (YD 859118) during the course of 27 Dec. An OF on Hill 93 (YD 845114) observed 12 missions in the south central portion of the TAOB.

H occupied a forward position with two guns at (YD 874108) at 280000H. The platoon fired four observed missions and two direct fire missions.

At 290810H CAC requested illumination at (YD 911116). Under illumination CAC engaged 4 VC with small arms fire and wounded one.

At 292150H illumination was fired for ARVN at (YD 897236) on VC activity. CAC requested and received illumination on a similar target at 252340H. No surveillance was received from either mission.

**LOGISTICS**

- a. **Supply.** Supply functions have been normal and no difficulties have been encountered that would adversely affect the units capabilities.
- b. **Maintenance.** A program of corrective maintenance necessitated by recent operations is nearing completion and a closely monitored preventive maintenance program has been initiated to cope with the climatic conditions of the area.
- c. **Food Services.** Force Logistics Support Unit Two has provided ample quantities of provisions. A limited refrigeration capability exists at present due to one of the 100 cubic foot units being inoperative while awaiting mechanical repairs.
- d. **Quarters and Camp Facilities development.** The construction of strongbacks under FAH 1110-102 continues at a satisfactory pace. Completion of the five hundred (500) man mess hall is anticipated within twenty (20) days.
- e. **Transportation and Roads.** There have been no significant modifications to the existing road system. Improvement of the helicopter landing site has been effected.
- f. **Fiscal.** No fiscal fluctuations of import have been noted to date.
- g. **Water.** Tests conducted on the unit's potable water at the point of consumption revealed it to be insufficiently chlorinated by current standards. Investigation revealed that a galvanized pipe leading from the water source to the Army 8th Rkt had rusted and was allowing contaminating seepage. Utilization of batch chlorination processes at the water point has eliminated the problem temporarily. Materials for replacement of the water pipe have been requested and the services of the local Mobile Construction Battalion are anticipated with regards to installation.
- h. **Motor Transportation.** No significant events have occurred within this area.
- i. **Embarkation.** Debarcation from the ships comprising the Ready Amphibious Group was completed on 24 December 1965 after slight delays incurred as a result of climatic conditions. The debarcation was accomplished by utilization of both surface and air craft and was quite successful.
- j. **Hospitalization and Evacuation.** No significant events have occurred. Adequate facilities appear to be provided by Company A, 3d Medical Battalion.

Medical and Dental Support

b. Significant events. The Battalion Aid Station assumed all medical functions in the facilities vacated by 3/4 on 23 December 1965. Medical supplies were broken out, emergency resuscitation made available and sterilization of instruments began.

c. Medical trends. 154 individual cases of diarrhea were treated during the reporting period. Laboratory results are incomplete at this time but both amoebic and bacillary dysentery are reported. Ice samples have been sent to Preventive Medicine Section "A" Med and DaNang. A progress report will be included in the next reporting period.

d. Number of battle casualties treated. Three.

e. Number of non-battle casualties treated. 366 men were treated at Battalion Aid Station during the reporting period.

f. Preventive medicine and sanitation. Malaria prophylaxis tablets are taken weekly by each individual attached to this unit. Messing facilities are inspected daily. Particular attention is given to food preparation, sanitizing of utensils and general maintenance of the area. Cooks and messmen are inspected every other day and have had laboratory examinations for amoebic dysentery. Head and urinal facilities are polished twice daily. Hand washing facilities have been provided for each head. Three times weekly each head is lined, burned and an application of residual insecticide is applied. Heads and urinals are mowed as necessary. Berthing spaces are inspected weekly to insure that perishable foods are not being stored or consumed in these spaces. Attention is given to maintenance and spacing of personnel. A sanitizing solution is furnished the barber shops to insure proper cleaning of combs, scissors and other instruments. All barbers have been instructed in the use of this solution. Barber shops are inspected three times a week. Erratic chlorine residual counts have been obtained from water procured from the Army water point. Therefore, the Engineer Platoon has erected a water point to insure a standard chlorine count is maintained. Hourly chlorine residual counts will be taken and the water point will be inspected daily. A substantial rodent population has been observed throughout the area. A crash program of poison baiting stations and live trap stations will be instituted. A progress report on this project will be included in the next reporting period. Good personal hygiene is being stressed to all hands.

Civil Affairs/Military Government/Community Relations

a. Significant activities.

(1) During the reporting period daily sick calls were held in the villages of Thuy Phu (912118), Loc Bon (925104) and Thuy Tan (911149), Huong Thuy District, Thua Thien Province. Corpomen assigned to the Combined Action Company personnel operating in these villages treated 611 Vietnamese.

(2) During the period 27 - 31 December the MedCap Team from B.A.S. 4th Battalion, 12th Marines treated 289 Vietnamese in the village of Phu Luong.

(3) On 26 December the contact team from "1" Company, Dental Detachment, 3rd Medical Battalion treated 94 patients at the Buddhist Orphanage in Hue.

(4) Marines and popular Forces of the Combined Action Company in Loc Bon (925104) constructed a road to serve the village headquarters complex. This project required approximately 16 man-hours to complete.

(5) On the night of 28 December one 2000 male Vietnamese was evacuated from Thuy Luong (882173) to "A" Company, 3rd Medical Battalion by helicopter. He was suffering from a strained hernia and could not be moved by vehicle. The patient underwent surgery and was held at "A" Med.

(5) On 29 December the Battalion Commander, accompanied by the Civil Affairs Officer, Civil Affairs Chief, Battalion Captain, and Combined Action Company Commander made a liaison visit to Huong Thuy District Headquarters. A briefing was presented by Captain THIG, District Chief and sub-sector Commander, on the state of affairs in his district. The Battalion Commander then visited and made the acquaintance of the village chiefs of Thuy Phuong (801182), Thuy Luong (882174), Thuy Tan (911149), Thuy Phu (912118) and Loc Bon (925104).

b. Material Distributed. On 29 December the village Chief of Loc Bon (925104) distributed clothing to 35 needy families within his village. The Squad Leader of the Combined Action Squad stationed in Loc Bon spent two (2) days with the Chief planning the distribution and selecting the recipients.

c. Special Civic Action Projects. No special civic action projects were undertaken during this reporting period.
