## Message from the President

**BASICS OF MILITARY RECORDS RESEARCH - By Ben Dickson Fox 2/1, 1968-69**

Most vets who start a process of VA compensation claims, replacement of DD-214's, or a quest for information on medals and awards are confused as to where to begin. Then there is the task of finding old buddies, or information about a unit, place, and battle and where one served. Let's face it our memories are not as sharp as we would think they are. Just sit around one of the tables at a reunion and listen to the comments about "gee, I didn't remember that!" I intend to start a primer on these subjects over the next few updates. Feel free to comment, correct me or add insights on how to help others.

One of the most common questions asked is "How do I get a copy of my DD-214?"

The dog ate it back in 1975, it burned up in a fire back in '80, my wife threw all that stuff out when we got divorced in '90---there are a million reasons why we don't have one and need it now. Have no fear. There is a place that keeps all military records. It is called the National Archives and Record Administration or NARA for short. The web site is [www.archives.gov](http://www.archives.gov) and has a wealth of information that is available to the vet. Most of the requests are done free of charge or at a nominal cost for copies. The site has a system called eVetRecs that allow you to request copies of your DD214, service records, medical records, and a host of other stuff. There is basic information that you must have to generate requests so be prepared ahead of time. The list includes:

- The veterans complete name used while in the service
- Service number
- Social Security number
- Branch of Service
- Dates of service
- Date and place of birth (especially if the service number is not known)

The site will have instructions on how to sign and date the request depending on whether you do it online or send in a form (SF-180) that can be downloaded. Next of kin are able to request deceased vets records by supplying information designated on the web site. If your request involves burial in a National Cemetery run by the VA, NARA will work directly with them to help you obtain the records needed. The info needed to do this is on the web site with phone numbers to fax, or in the case of Marines, a Liaison Officer number who will help.

This is the basic starting point of most research about a vet or to process a claim with the VA. In the next few updates we will discuss how to obtain your Military Service Records, places to obtain your Medical Records, how to apply to get a replacement set of medals, how to Correct Service records and Discharges. We will also discuss the National Personnel Records Center and what their function and role is.

Many vets will say "my records got burned up in the NPRC fire". It is true that 16-18 million records were lost in the fire in St. Louis in 1973. Millions of records had been loaned out to other agencies at that time so there are alternate sources to find them. As Viet vets, we really don't have to worry about it because of the time frame of the records involved. These are the services and years involved in the loss:

Army-	Personnel discharged 1 Nov 1912 to 1 Jan 1960	80% loss
Air Force-	Personnel discharged 25 Sept 1947 to 1 Jan 1964	75% loss

So if some Marine tells you that they don't have records because of the fire and they were not in these time frames they are either smoking some weird stuff, or maybe their service is a little suspect. Good luck with your searches.

From 29 April to 2 May 2010, the officers and trustees met in San Antonio to reconnoiter the area for the 2010 reunion. If you have any doubts about going to San Antonio (SA) this November, please read on and I will dispel them.

San Antonio (SA) is very visitor and reunion/convention friendly and your reunion committee, has successfully negotiated with the El Tropicano Riverwalk hotel to provide us with a rock bottom room rate as well as other perks for our stay. Our point man in SA is Gary Gordon and he has done a great job of setting things in motion to showcase Texas hospitality.

San Antonio is famous for the Alamo but a precious jewel, just outside the hotel, is its renowned Riverwalk. A short, 5 or 6 block walk along the river toward the center of the SA brings you to an intersection; turning left will put you on the Riverwalk Loop. On this Loop you will find hundreds of eateries, restaurants and bars. At street level, shops of all kinds await the interested buyer along with more restaurants, the Market Square, (more shops), Mexican Fiesta, Rivercenter Mall and, of course, the Alamo. Getting around is a snap with the blue and red water taxis: blue will take you where you want to go and red will take you on a tour. If you want to venture a little farther, the Trolley that stops just outside the hotel is available to get you there. Other sites within a short distance of the city are Sea World, Six Flags, Lackland Air Force Base, the Mission Trail (remember the Spaniards), A Taste of Texas Wine (who knew), Wimberley Glassworks (watch it done), Natural Bridge Caverns, Louis Tussauds' Wax Works and Fort Sam Houston. A little farther still in Kerrville is a real nice western museum and in Fredericksburg, the Nimitz Museum (Nation Museum of the Pacific War).

Taking a 5 or 6 block stroll from out hotel in the opposite direction brings you to VFW Post 76, the oldest post in Texas. Eighty percent of its membership served in the Marine Corp; some of the members either served in 2/1 or supported 2/1's activities in Vietnam. Needless to say we received an enthusiastic welcome. When we return in November, we were assured that their doors will be open to us and they will support us in any way they can.

Our former 2/1 S-3 in Vietnam Col. Willie Wright has graciously offered to host a Texas style BBQ at his ranch just outside of SA. Transportation from the hotel will be provided or directions if you prefer to drive.

I want to encourage you to come to San Antonio. The reunion is sure to be a memorable one. San Antonio offers an abundance of sights and activities for all (that means wives too!), so consider arriving a few days before the reunion or staying a few days after. You will not be disappointed.

**2/1 - The Beginning. - Bob Hughes**

Everytime I attend a reunion, I get one or two people who thank me for putting 2/1 together. I try to explain that it was not me, but I still get the credit. Well, I think it is time to put the story down in an article so everyone will be on the same page. You see, there are a lot of people responsible for the present 2/1 Organization, and you might, or will be one.

The story starts in or about 1976. I was at home, drunk, and thought it would be neat to find what was left of my Vietnam group, Hotel 2/1, 3rd Platoon, 1966 - 1967. So I started to call around to areas I thought some of the guys came from with the help of a few long distance operators. Well, the next morning I had one hell of a hang-over and "no hits" on the people I was looking for.

The next time I thought about locating the guys was in 1983. I saw several ads in various military newspapers and magazines listing a reunion for Hotel 2/5, so I called the number listed. I did not remember a Hotel 2/5 being in Vietnam, so I thought it might be a "type-o". I talked to a Charlie McMahon who said it was Hotel 2/5, but the group would love to have me attend their get together, you know, "brother Marines" and all. I politely declined, but Charlie said I should talk to their "LT", so he took my phone number.

Within a day or two, I received a call from Ken Kromer, their "LT". He also extended me an invitation and I again politely declined. That is when Ken hit me between the eyes with this statement "It is better to attend the wrong reunion than no reunion at all". I thank him for his offer again and hung up. The next few days that statement, "It is better to attend the wrong reunion than no reunion at all" kept popping up in my brain. It was profound, and I kept thinking more and more about it.

The only 2/1 veteran that I had met since my medical retirement was "Doc" Steve Harper, the Corpsman that had treated me for my first wounding in Vietnam. We found each other by telling the 2/1 story of "A Shot in the Dark". There is more to that episode, but that is for another time. Anyway, I called Doc and told him about the reunion for H 2/5 in Washington, D.C. and Ken Kromer's statement. I said I owed Doc a "house call" payment, and if he would go with me I would pick up the tab. Doc Harper said yes, and we were off. If Doc had said no I am sure I would not have gone.

The reunion was on the Marine Corps Birthday in 1983, and yes Paul, the Birthday fell on the same day in that year too! Doc and I were well received and had a great time. Thirty-nine (39) members showed up for the get together, along with a few wives and kids. They had a sit down banquet that was quite impressive. On the way home from Washington D.C. Doc and I started to talk about how great it would be if we could get what was left of the "Third Herd" (H 2/1 3rd Plt.) together. So, we started to make a list of people we could remember. We also tried to remember what state they were from. We also decided to run ads.

As time passed, Doc and I found that we were having more success with the ads run in the military magazines and newspapers than by trying to locate people by phone. There was a catch though with the people that were responding to the ads, none were my "Third Herd" personnel. They were veterans of the Hotel Company 2/1 Vietnam experience, but from other time periods in 3rd Platoon, members of 1st and 2nd Platoon and lastly, other 2/1 Companies. All pretty much said the same thing, that nobody was putting anything together for their specific groups and can they "hang around" with us. Of course the answer was yes.

By March of 1984, there were over 30 people in the Hotel 2/1 group, and each month, more people were popping up. To keep everyone up to date, and let them know who else had joined us, I started to send out a Hotel Company Newsletter to all the members. Around the end of March or April 1984, one of the "Third Herd" guys contacted me. We talked for quite a long time, and at the end of our talk, he put me in touch with about another six or seven guys from the "Herd".

Once we connected, and found that most lived on the east coast, we set up a reunion for the Marine Corps Birthday in November 1984, the year that the statue was dedicated. There were about twenty-four 2/1 veterans (plus wives and kids) who attended the first reunion at the Holiday Inn at C Street, Washington D.C. under the name Hotel Company.

I had yellow tee shirts in various sizes and yellow ball caps printed up with the logo HOTEL COMPANY 2/1 VIETNAM in red, which I sold at cost. Everyone was wearing them, guys from Echo, Foxtrot, Golf and H&S. I even believe one or two buddies of 2/1 veterans bought some and were wearing them around the hotel.

From that time on we did a reunion each year. Our group grew, but there is a reason for that and it was NOT MY DOING. 2/1 came about due to a number of things and a number of people. Follow me on this.

**First**, if it was not for the H 2/5 ads, then Ken Krommer with his insistence and statement (wrong reunion vs. no reunion), I would have never gone to Washington or anything else. **Second**, if Doc Harper had not said yes to going and he and I had not had a great time, we would never had talked about finding the "Third Herd". **Third**, if the 2/1 guys from other time periods and companies had not responded to the ads, Doc and I would have given up OR ended up with the "Third Herd" guys only.

**Fourth**, that the 2/1 guys went out on their own to find more of their buddies which seriously increased the number of 2/1 veterans. **Fifth**, that a number of "Third Herd" guys were found, and in turn found more people. **Sixth**, Doc Johnson had become very active in the group and realized that I was getting burned out with the newsletter and took over that responsibility.

**Seventh**, David and Marion Novak sponsoring, editing and producing the "WE REMEMBER" books, I and II. **Eighth**, when I stepped down in 1995, Mike Rodriguez and others stepped up to continue on. **Ninth**, Pete Meadows started to run an internet Sunday morning "coffee" newsletter that was very popular.

**Tenth**, past and present officers (Paul, Phil, Mario and Ben and others). **Eleventh**, Vin Burdziuk, the 2/1 Web Master, with his great web page. **Last**, but not least, the great Board of Directors, present and past.

The truth is, **THERE ARE A GREAT NUMBER OF PEOPLE AND THINGS THAT HAVE GOTTEN 2/1 TO ITS PRESENT POSITION**. So, I now ask that the next time you hear someone say that it was Bob Hughes who put this thing together, **SET THEM STRAIGHT, EVERYONE HAS HAD A HAND IN IT !** See you in San Antonio, Bob Hughes

Lieutenant Colonel & Contingency Plans Officer, Assistant Chief of Staff, C-5, United Nations Command and ROK/US Combined Forces Command, Seoul, Korea. 1990 7th Marine Expeditionary Brigade, Twenty-nine Palms, Brigade Plans Officer for Operation Desert Shield. Lead operational planner for I Marine Expeditionary Force offensive for Operation Desert Storm.
