



2. ENEMY, WEATHER AND TERRAIN

a. General. Enemy contact was light to moderate with very few instances of enemy initiated contacts. Enemy mining activity, heavy last month, increased significantly, but the potential devastating effects of this increase were largely offset by the effects of the rewards program and a general improvement in the proficiency of personnel in the field in detecting mines. The mine sweep activities by the companies accounted for a large percentage of mines found. The rewards program accounted for the recovery of 141 pieces of enemy ordnance. Twelve (12) mines were detonated and forty-nine, (49) were destroyed by Marines during the month.

Several intelligence targets in the HAI LANG NATIONAL FOREST AREA were engaged by artillery missions and air strikes in November. Supporting arms fired on suspected locations of NVA units, an NVA training area, and a draftee indoctrination center.

On 10 November, a local VC cadre member turned himself over to a Marine unit in the hamlet of NHU LE and two days later led them to 17 tons of rice, four (4) weapons, four (4) mines and grenades the following day. Intelligence reports from agents indicate that loss of rice has seriously affected NVA units operating in that particular area.



d. Weather and Terrain

(1) Weather. During the month of November weather has been generally mild with variable amounts of precipitation and has had little effect on combat operations in the QUANG TRI Combat Base.

3. Organization and Operations

a. Continuous patrols and ambushes characterized daily operations in the 2nd Battalion TAOR in November. During this second month of operations south of QUANG TRI City activities were conducted on a generally smaller scale and many more platoon and squad patrols were conducted than in October due to increased familiarity with the terrain and the enemy situation. Both day and night ambush patrols and observation posts were conducted in the most likely and frequently used avenues of infiltration with emphasis on trail approaches from the forests to the south and west and the rivers on the east and west boundaries of the TAOR. On three occasions individual companies conducted search and clear operations in NHU LE, PHU LONG and TRUONG PHUC Hamlets. These operations netted one VC and one NVA killed and several detainees. There were intermittent contacts throughout the TAOR, most of which were incidents with unobserved snipers and observations of small groups of VC.

The companies of this battalion made moderate progress in mine sweeping and clearing operations during November. These operations were directed towards specific areas known to be heavily mined, and they incorporated the personnel and electronic mine detectors of the attached engineer platoon from the 1st Engineer Battalion. On one occasion 21 mines were detected in a single day by Co "G" in conjunction with the mine clearing plan. An additional mission accomplished by 2nd Battalion included security on a nightly basis at Battery "A", 1st Battalion, 11th Marines.

b. During the period 4-17 November companies E and G joined OPCON 1st Battalion for Operation LANG STER with the 3rd Marines near CON THIEN.

Abundant Intelligence reports were the focal point of much local operational planning during November and three operations were conducted for the 1st Marine Regiment by 2nd Battalion in acting upon some of the critical ones. On 1 November the Battalion Command Group and Companies F, H, and C of 1st Battalion conducted an operation near hill #80 in conjunction with reports of NVA/VC rocket storage areas near that location. One company of ARVN Armored Personnel Carriers provided support during this operation; there were no contacts with enemy forces, and no indications of the rocket caches were found.

A major contribution to this battalion's input of intelligence data came on 10 November when a local Viet Cong guerilla surrendered under provisions of the CHIEU HOI program, and under interrogation he provided information on the whereabouts of two major VC rice caches in the forests south of this CP. On 11-12 November Companies F and C, 1/1 with the Battalion Command Group deployed with the help of the former VC located and destroyed 17 tons of rice and a substantial amount of salt stored by the VC. Again on 20 November the Command Group with companies F and H landed by helicopter near hill #31 and conducted a one day search for another rice cache. This operation netted one NVA Killed and several documents captured, but failed to discover additional rice. On 27 November companies E and F of 2nd Battalion participated with 2nd Battalion, 4th Marines and a task force of ARVN military and para-military forces in a cordon and search of NHU LE Hamlet.

c. Air

(1) Helicopter

1st Marine Aircraft wing helicopters in support of 2nd Battalion, 1st Marines lifted 24 USMC WIA and 3 USMC KIA on 12 emergency medevac missions. There were 8 priority medevac missions lifting 16 USMC WIA, 3 USMC Kill, and 1 civilian WIA.

Six Recon flights were made during the month carrying unit commanders, operations, and Intelligence personnel over planned operating areas.

Five Passenger pickups were made at 2/1.

November 20, 12 UH-34 helicopters lifted 2 companies and the command group on a one day search mission; 400 troops were inserted in approximately two hours. The extract of the 400 troops took 12 UH-34's and 2 CH-53's slightly over one hour. One section of UH1E helicopters provided fire support, expending 48 2.75" FFAR Rockets and 1000 rounds of 7.62mm.

On 29 November two 1st MAW UH-34 helicopters resupplied H Co with 1025 lbs of cargo and transported 3 passengers to their positions.

(2) Fixed Wing

Aerial observer support for the 2nd battalion continued to be infrequent due to heavy commitments in other Operations areas. A.O.'s flew seven missions for this battalion during November.

There were 12 close air support sorties flown in November. Ordnance dropped included 54-250 lb bombs, 86-500 lb bombs, 4-1000 lb bombs, 2-2000 lb bombs, and 475 rounds of 20mm. These air strikes accounted for one VC KIA (CONF), two VC KIA (PROB), 10 bunkers and 25 fighting holes destroyed, and 2 secondary explosions.

d. Artillery and Fire Support

(1) During the Month of November supporting arms fired 143 missions expending 1125 rounds. There were 796 H&I Fires expending 5469 rounds. Battalion 81mm mortars fired 25 missions expending 374 rounds and 228 H&I Fires expending 1456 rounds.

Battery A 1st Battalion 11th Marines continued to provide direct support to this battalion. Battery "W", 1st Battalion 11th Marines continued to be located in this CP in general support of 1st Marines.

(2) FSCC accompanied the battalion Command Group on three occasions. One section of 81mm mortars displaced on one occasion.

4. Training

A new program of instruction was put into action during November in which personnel in Companies E, F, and H received formal instruction in General military subjects, tactics, and weapons. Each of these companies attended classes over a five day period during which they were relieved of most commitments in the field in order to accomplish maximum training. Three General Purpose tents were set aside for classes and other training aids were constructed including a new firing range for small arms and all other weapons inherent to the battalion. Two companies were trained by personnel supplied by the operations section, but Company E employed its own personnel to teach classes from the same curriculum. Changes in scheduling were made continuously to achieve maximum efficiency and best usage of time and personnel; this will be especially important in the future as companies alternately conduct training and operations in the field on a daily basis. Courses taught in the school included combat intelligence; basic communications; ambush and patrolling techniques; combat orders and tactics; map and compass reading; leadership; field sanitation; first aid and medevac techniques; mines and booby-traps; and M-16 firing, and care and cleaning techniques. An inspection of the company by the commanding officer was conducted in conjunction with each week of instruction to better judge the readiness and effectiveness of the company. The purpose of the entire program of refresher-type training was to ensure the continued proficiency of the individual rifleman in the skills so important to his trade.

Weapons instruction was emphasized during November through the company schools with formal instruction and by installation of a new firing range immediately south of the Battalion CP. This range was constructed to accommodate both light and heavy, direct and indirect fire weapons. Targets were permanently installed at ranges of 300 and 600 meters in several configurations depicting enemy troops in column, on line, and in other formations. Indoctrination of replacement personnel on the M-16 continued steadily during November as 298 Marines received the 8 hour course including zeroing their new weapons, and firing of 300 rounds in regular marksmanship training.

c. Motor Transport. Spare parts for Miles (M-422A1) and Miles (M-274A2) continued in critical status during the November reporting period.

d. Roads. Access roads and the main supply route remained passable, no obstructions (mines, etc.) were encountered during the month of November.

e. Fiscal obligations for the month of November for FSA was \$88,867.33.

f. During November 199 Tactical Equipment Repair Orders were submitted to FLSU. Of these, 19 were completed. As of 30 November 59 items of combat essential equipment were deadlined.

6. Civil Affairs experienced during the month of November in locating a suitable trash and garbage disposal sight for the Battalion Mess Hall. No problems were experienced in areas of hospitalization-evacuation.

6. Civic Action

During November Civil Affairs personnel made several contacts with civilian organizations concerning future Civic Action projects. Materials were procured at Dong Ha to build a McCap building in LZ VLF, and construction was completed on 29 November. Civil Affairs continued to conduct business at the Vietnamese concession stand and Barber shop.

7. Psychological War

Intensive work was done by the Civil Affairs section during November in distribution of leaflets for the areas immediately adjacent to the Battalion CP. During patrols by pay-off personnel as well as during patrols and operations by the rifle companies leaflets were handed out and broadcasts made on the "12" 11 program (12,000), Mine Reward program (19,000), PGM KEP (4,000), and VC Atrocities (10,000). The Mine Reward leaflets were well received by the local population, and 141 pieces of ordnance were turned in to the 2nd Battalion, 1st Marines.

On one occasion a Vietnamese Armed Propaganda Team was employed with Company F in NHU LE Hamlet and much effort was given to publicity after a Viet Cong cadre member surrendered to Marines in NHU LE. No tangible results have been seen from this program to date.

8. Communications

Wire installed a seven phone loop for "F" Company defensive position, and installed an SB-22 in the CO's bunker with seven lines to coordinate night defensive lines. Tech shop second echeloned all battalion radios and later waterproofed them in preparation for the monsoon, inspected all wire equipment and repaired or turned in to FLSU-1 all defective equipment. Table of equipment was brought up to date as was section embarkation. Modification and maintenance cards were also brought up to date.

9. Medical and Dental.

Twenty-three combat casualties and 6-0 sick-call patients were treated at the Battalion Aid Station during the month of November. There were no cases of Malaria during this period. Eight cases of Immersion Foot were treated at this facility during the month of November.

10. Chaplain

a. Protestant Divine Services. The Battalion Chaplain, LCDR A. H. WHITE, CHG, USNR, is Protestant. Eight Protestant Divine Services were held on Sundays during the month of November. Four of these were held in the 2nd Battalion, 1st Marines Command Post area; one was held at the 1st Marines, MV 36, 1st Battalion, MACV and 2nd Battalion, 4th Marines. A total of 197 persons attended Sunday Divine Services during November. Five weekday Divine Services were held. A total of 13 persons attended these. A total of 13 Protestant Divine Services were held with a total of 250 persons attending.

b. Catholic Divine Services. Catholic Divine Services for 2nd Battalion were conducted by Chaplains R. V. LINDS and JOHN MCELROY. Three Catholic Services were held on Sundays and one weekday. There were a total of 152 persons attending.

c. Lay Leader Services. There were four Latter Day Saints services held at the 1st Marine Regiment. Sixteen persons attended from 2nd Battalion.

d. Visits. During November the Battalion Chaplain made seven visits to "B" Medical Hospital, one to NS, and one to 1st Medical Hospital. There were 54 patients visited.

e. Counseling Sessions. The Battalion Chaplain counseled with 19 Marines regarding personal matters.

f. Red Cross Messages. The Battalion Chaplain delivered six Red Cross Health and Welfare messages. He also sent, through the Regiment Red Cross representative, five requests for health and welfare checks on families for men of 2nd Battalion.

a. Memorial Services. The Battalion Chaplain conducted three Memorial Services in November. A letter and Memorial bulletin were sent to the next of kin.

b. Conferences. The Battalion Chaplain attended one Division Chaplain's conference and three Regimental Chaplain's conferences. One Personnel Response conference was attended by the Battalion.

c. Scripture Distribution. Twenty-one New Testaments were given to personnel. All types religious literature were available in the Chaplain's office.

d. Correspondence. Eighty-one letters of condolence were mailed out to relatives and Officers' next of kin dealing with permanent fatalities reported individually.
